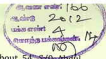

WHEREAS the Trustees have always been desirous of promoting Educational and connected charitable activities and establishing an Educational Trust for carrying out educational activities for the benefit of General Public, as set out in the object clauses,

AND WHEREAS, for the above said purposes, the Trustees of the Trust have set apart a sum of Rs.15000/- (Rupees Fifteen thousand only)(i.e. Rs.1000 by each Trustee) out of their own funds and have agreed that donations, gifts, contributions to be received from General Public, other Institutions having similar objects and State/Central Government departments shall be utilized towards the promotion of the objects of the Trust and incidental activities connected there with.

The Trustees of the Trust hereby confirm that the sum of Rs.15000/- (Rupees fifteen thousand only) shall be held as corpus of the Trust.

NOW THIS DEED OF DECLARATION OF PUBLIC EDUCATIONAL TRUST WITNESSETH AS FOLLOWS:-

1. The trust hereby established shall be known as "VISION EDUCATIONAL TRUST" or such other name as may be decided by the Board of Trustees if such need arises and shall here in after be referred to as the "TRUST"
2. The registered office of the trust shall be located at Door No.90/2, Aliyar Street, Kayalpatnam, Tuticorin district, Tamil Nadu, India or such other place or places as may be decided by the Board of Trustees from time to time.

BOARD OF TRUSTEES AND POWERS

The above Trustees shall constitute a First Board of Trustee who shall be competent to co-opt any person or persons as a Trustee or Trustees for the better and proper administration of the Trust. The board of trustees shall choose among themselves office bearers for proper administration of the activities of the trust and their period of office will be three years.

4. Mr. T.A.S.MOHAMED ABOOBUCKER-the 1st Trustee shall be the "PRESIDENT" of the Trust and shall hold the office for first three years and however he is eligible to be re elected by the board of trustees. He shall preside over the trust meetings and supervise the whole affairs of the trust.

Mr. A.A.C NAWAZ AHAMED - the third Trustee shall be the "SECRETARY" of the trust and shall hold the office for first three years and however he is eligible to be re elected by the board of trustees. He shall exercise all the powers of supervision, direction

and control of the entire affairs of the trust. He shall be responsible for the submission of report on the activities of the trust during every meeting of the trust. In his absence; any trustee duly authorized by the board of Trustees shall exercise such powers and functions.

6. Mr. L.K.K.LABBAI THAMBY- the 4th Trustee shall be the "TREASURER" of the Trust and shall hold the office for first three years and however he is eligible to be re elected by the board of trustees. He shall ensure proper maintenance of accounts and be responsible for all receipts and expenditure of the trust.

7. The number of Trustees shall not be less than 3, but not more than 21 at any point of time.

8. The Board of Trustees shall have powers to frame rules and regulations for the proper conduct and administration of the Trust, but any such rule or regulation shall not be against the objects of the Trust or any condition or clause of the Trust deed.

The Board of the Trustees shall have powers to appoint employees for the purpose of carrying out the objects of the Trust and also to fix terms and conditions of employment.

10. The Board of Trustees shall have powers to appoint legal advisers, Chartered Accountants and such other professionals on such terms and conditions as the Board of Trustees may deem fit from time to time.

11. The Board of Trustees is authorized to borrow money for carrying out the objects of the Trust from Nationalized banks, Scheduled banks, Financial institutions or from others.

12. The Board of Trustees shall have powers to acquire capital assets in the name of the Trust and likewise dispose them of subject to the provisions of the Income Tax Act, 1961.

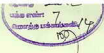

13. The Board of Trustees shall hold the properties to be purchased in future in the name of the Trust only. At present, the Trust has no movable/immovable property.
14. The Board of Trustees shall have powers to sell, mortgage, lease out or otherwise deal with any of the properties to be purchased in future and utilize the proceeds for carrying out the objects of the Trust.
15. The Trustees shall render service to the Trust free of charge with service motive. However actual expenditure if any incurred by them for and on behalf of the trust shall be reimbursed to them out of the funds of the Trust.
16. The Board of Trustees shall have powers to receive donations, contributions, gifts from the General Public, other Institutions and State/Central Government departments and utilize the same for carrying out the objects of the Trust.
17. The Board of Trustees shall have powers to file suits on behalf of the Trust and likewise to defend any action taken against the Trust and also to compromise and compound such cases.
18. All matters relating to appointments, removals or re-nomination of employees and their remuneration etc, shall be decided by the Board of Trustees.
19. The trust shall open account in any Nationalised bank/Scheduled Bank and the Bank account shall be operated jointly by either two of the three i.e., the president, the secretary and the Treasurer or by any trustee or trustees duly authorized by the Board of Trustees.

20. The Board of Trustees shall meet as often as possible or at least once in 3 months for discussion about the objects already carried out and proposed to be carried out in future. They have also right to take decisions even by circulation of resolutions or matters among the trustees.
21. All the decisions of the Board of Trustees shall be taken unanimously or by simple majority and if the board is divided equally, then the chairman of the meeting (normally the president) shall exercise his casting vote and bring the matter to an end.
22. The quorum for any meeting shall be more than 50% of the surviving trustees. However this can be revised.
23. No act or resolution of the Board of Trustees shall become invalid merely by reason of there being one or more vacancies in the Board of Trustees.
24. A Trustee who is unable to be present at a meeting of the trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.
25. The minutes of the proceedings of every meeting of the trust shall be entered in a book to be kept for that purpose and signed by the presiding trustee of such meeting. The Trust shall be guided by all decisions taken at those meeting and recorded in the minutes book.
26. A trustee may appoint a nominee during his life time and such nominee should be approved by the majority of the trustees.
27. All documents, deeds, titles of the Trust shall at the first instance, be executed, endorsed, signed by the President and Secretary or Treasurer.

28. In case of death or resignation of any trustee the person nominated by him in his life time may be appointed as a new trustee in his place with the consent of the trustees.

29. Any person being

- a. An undercharged insolvent
- b. Convicted of an offence involving moral turpitude
- c. Of unsound mind or
- d. A Minor

Shall not be eligible or to continue to be a trustee.

30. A person shall cease to be a trustee in any part of the following events viz

- A. If he/she becomes bankrupt
- B. if he/she becomes insane or otherwise become incapable to act

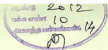

C. if he/she resigns his/her post

31. A trustee can be removed by 4/5th vote of other trustees against him for the serious misconduct in relation to Trust property or in the welfare of the Trust activity after giving a reasonable opportunity to justify his conduct. Any decision of the Board of Trustees in this behalf shall be final and binding and shall not be called up on in courts or otherwise.

OBJECTS OF THE TRUST

32. The objects for which the Trust Fund is established are education, relief to the poor and advancement of any other charitable objects of general public utility not involving in to any activity of profit nature.



33. The Trust shall establish, run, maintain, develop, promote and take over educational Institutions of all kinds such as schools, colleges, coaching centre, technical, non-technical, professional, non-professional educational centre for the benefit of General Public irrespective of caste, creed, religion, community, sex etc.
34. The Trust shall strive hard to give best knowledge based quality education to people. For achieving this, the Trust will organize and support all kinds of educational awareness programs, coaching guidance and shall encourage and assist students through various scholarships.
35. To enlighten the future generations with modern education along with secular education.
36. The Trust shall support similar organizations through guidance and arrangements shall be made with like-minded institutions and trusts and will help in achieving the target of useful education to all people.
37. The Trust shall establish, run, maintain develop scientific and research based institutions to cultivate scientific knowledge in the minds of the students.
38. To render financial assistance to the needy poor students for purchasing school books, note books, uniform, other study materials and for the payment of educational fees.
39. To render financial assistance to the other institutions having similar objects and which enjoy recognition under section 80-G of the Income Tax Act, 1961.
40. The funds including surplus funds of the Trust shall be invested in the specified investments in accordance with the provisions of section 11(5) read with section 13(1) (d) of the Income Tax Act, 1961

41. The Trust shall be irrevocable one.
42. In the event of dissolution/winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among trustees, but the same shall be transferred to other institution having similar objects.
43. If powers to effect amendments to the Trust Deed are delegated to the Trustees, it would not extend to altering the basic character of the Trust and further, no such amendments which may prove to be repugnant to the provisions of section 2(15), 11,12,13, and 80-G of the Income Tax Act, 1961 shall be made.
44. Amendments, if any, to the Trust Deed shall be carried out only with the prior approval of the Commissioner of Income Tax.
45. The benefits of the Trust are open to all irrespective of caste, creed, religion, community, sex etc.
46. The objects/activities of the Trust shall be carried out only in India.
47. The accounts of the Trust shall be maintained regularly and every year, the accounts shall be closed by 31st March and the same shall be audited by a qualified Chartered Accountant.
48. The income of the Trust will solely be utilized towards promotion of the objects of the trust and no part of income or fund will be utilized either directly or indirectly to the Trustees or to their relatives on any account either by way of profit, dividend interest or otherwise.
49. The Trust shall not carry on any business or perform or conduct any activity in the nature of business with profit motive.

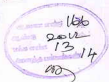
